



CODE OF CONDUCT AND WORK OF MEDIA REPRESENTATIVES AT THE INTERNATIONAL RUSSIA EXPO

To hold the International RUSSIA EXPO and to create conditions for professional and efficient work of mass media representatives, each representative of the media must follow the Code of Conduct and Work listed below at the facilities of the Exhibition.

Any of the following points may result in the withdrawal of accreditation:

- 1) aggressive, offensive or discriminatory behavior towards the organizers' personnel, volunteers, guests and participants of the Exhibition, presence at the facilities of the Exhibition under the influence of alcohol or drugs;
- 2) refusal to follow the rules and instructions of the organizers and security personnel;
- 3) deliberate obstruction of the work of other accredited media representatives;
- 4) willful damage, copying, total or partial counterfeiting of accreditation badges, as well as other cases of misuse of accreditation, including but not limited to attempted sale, handover to third parties;
- 5) willful damage, copying, total or partial counterfeiting of additional means of access (extenders, etc.), and other cases of misuse, including but not limited to attempted sale, handover to third parties;
- 6) violation of zoning, as well as visiting the interior areas of the facilities of the Exhibition without being accompanied by the Press Office Department staff;
- 7) interfering with the work of artists in the Cultural Projects Area (artists talk to media ONLY after a respective request for an interview has been approved by their press services, please, contact their representatives in advance if you want to arrange for an interview);
- 8) failing to follow the rule to indicate the source when using texts, photos or other materials published on the russia.ru website, in accordance with the following spelling: International RUSSIA EXPO (abbreviated RUSSIA EXPO), Autonomous noncommercial organization «Directorate of the Exhibition of Achievements "Russia"» (abbreviated ANO «DEA "Russia"»);
- 9) filming and taking pictures of people without their consent;
- 10) filming and taking photos in the security inspection area, unless it was authorized by the Press Office Department.

Rules of work in the media zones

In the media work zones it is not allowed to:

- 1) rearrange furniture and reorganize workplaces at your discretion;
- 2) reserve workplaces by any means;
- 3) take photos/video footage of office premises and employees of the Directorate without their consent.

Rules of work for photographers/cameramen/bloggers

Photographers, cameramen, and bloggers must follow the working rules below:

- 1) not use flash/additional lighting when shooting during press conferences;
- 2) not record video with a photo camera, not record audio with any devices, including telephones (except for bloggers);
- 3) not hinder the work of photographers/cameramen/bloggers and other media representatives at press conferences and in all media areas;
- 4) not use the tripod in the Halls A and B of the Pavilion 75 when filming.
